2015 PROGRAM ACCOMPLISHMENTS

Financial Assistance

Our primary program is to provide financial assistance to our families. In 2015, Ally's House processed financial assistance applications for 94 families. This was an increase from the previous year. The families ranged from infants to teens whose hometowns were all across the state.

Camp Live-A-Dream

In Camp Live-a-Dream's second year as a program of Ally's House, we served 35 campers, including 4 counselors-in-training (CITs). With a theme of superheroes, campers enjoyed an outing to a trampoline park, a night of skits and songs, and Karaoke night.

Christmas Elf

As an annual holiday program, Christmas Elf continued to be a hit with both kids and "elves". The program features donor "elves" who are given a list of items a patient might enjoy. The elves, with a \$50 guideline, then bring a gift to Ally's House for delivery to the child. In 2015, 29 children were blessed by their own Christmas Elf.
